Sunshine Law

Following approval of the agenda and Committee member introductions, *Steven Carter* reminded the Committee that the Florida Greenways and Trails Council is bound by the Sunshine Law (s. 286.011, F.S.), which states that any gathering of two or more Council/Committee members to discuss Council/Committee business must be scheduled and open to the public with proper notice and minutes/recordings taken.

Unpaved Trail Guidelines Discussion:

Trail Construction

Hiking Trails – The Committee began their discussions with the 'hiking trails' section of Trail Construction and recommended additional considerations for the materials used on hiking trails in addition to all other trail types.

Additionally, the Committee recommended the addition of a trail safety/first responder paragraph within each trail type under the Trail Construction section.

Off-road Cycling Trails – During their discussion of cycling trails, the Committee recommended updates for tread width, turning radius, technical trail features and trail rating in addition to the addition of verbiage regarding the expanding diversity of cycling trails.

Equestrian Trails – Regarding Equestrian Trails, the Committee recommended updates to 'Clearing Width,' 'Vertical Clearance' and ride lengths. Additionally, the Committee recommended new paragraphs for signage, bridges, water crossings and trailheads.

Unpaved Multi-Use Trails – The Committee provided recommendations for new updates to account for equestrian user groups as appropriate, increase horizontal clearance and provide additional examples for trail location.

Trail Crossings

During their discussion on Trail Crossings, the Committee recommended the inclusion of FDOT's Design Resources as an additional reference. They also recommended updates to visibility standards, boundary crossings and seasonal use guidelines.

Additionally, the Committee decided to recommend the addition of a paragraph on abovegrade crossings (bridges) for each trail type listed under the Trail Construction section.
